## **DEFINITION:**

Equipment: Tangible items non-expendable in nature, such as furniture, instruments, or repairable machines that have a useful life of more than one year and an acquisition cost of \$1000(State of MS Threshold) and \$5000 or greater (Federal Threshold) and any exceptions which meet or exceed the established thresholds for defining equipment. Equipment is not replacement parts or components returning a piece of equipment to its original condition. If a component increases the capability of the original equipment and has an acquisition cost that meets or exceeds the established equipment cost thresholds, it is condered a capital item.
